

**TAX LEVY ORDINANCE
Ordinance No. 2012-1**

AN ORDINANCE OF THE BOROUGH OF LANGHORNE, County of Bucks, Commonwealth of Pennsylvania, fixing the tax rate for the year of 2012.

BE IT ORDAINED AND ENACTED, and it is hereby ordained and enacted by the Borough Council of the Borough of Langhorne, County of Bucks, Commonwealth of Pennsylvania:

That a tax be and the same is hereby levied on all real property within the Borough of Langhorne subject to taxation for the fiscal year of 2012 as follows:

	By anticipated 2012 millage/assessments
Tax rate for general purposes, the sum of On each dollar of assessed valuation, or the sum of On each one hundred dollars of assessed valuation.	8.25 mills .0825 cents
For Street Lighting purposes, the sum of On each dollar of assessed valuation, or the sum of On each one hundred dollars of assessed valuation	2.2 mills .022 cents
For Fire Tax purposes, the sum of On each dollar of assessed valuation, or the sum of On each one hundred dollars of assessed valuation	1.65 mills .0165 cents
For Rescue Squad Tax purposes, the sum of On each dollar of assessed valuation, or the sum of On each one hundred dollars of assessed valuation	.06875 mills .006875 cents
For Shade Tree Tax purposes, the sum of On each dollar of assessed valuation, or the sum of On each one hundred dollars of assessed valuation	.0275 mills .00275 cents
